WAIVER AND RELEASE OF LIABILITY FORM

(ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT)

By signing this document you will waive certain legal rights including the right to sue

ASSUMPTION OF RISK

1) I, the undersigned, wish to play **Paintball**. I recognize and understand that playing **Paintball** (hereinafter called the 'Game') involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible Malfunction of the equipment used in the Game and injuries resulting from tripping or falling over obstacles in the Game playing field. In addition, I recognize that the exertion of playing the Game could result in injury or death.

2) Despite these and other risks, and fully understanding such risks, I wish to play the Game and hereby assume the risks of playing the Game. I also hereby hold harmless the 'Sponsors' and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including, without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of any and all equipment used in the Game. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or any other ailment which could be exacerbated by the exertion involved in playing the Game. I further certify that I am 18 years of age or older.

AGREEMENT RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY

In consideration of participating in the Game, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have, or may in the future have, against

2. **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expense that I may suffer,

INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;

3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any damage to property of,

or personal injury to, any third party, resulting from my participation in the Game;

4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns,

in the event of my death.

PLEASE READ CAREFULLY

I HAVE READ AND UNDERSTOOD THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.

5. I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event in which I participate hereafter.

Said releases shall further assign 1747434 Ontario INC, trading and operating under the name sector 57 all rights to use any photographs or video of me taken relative to playing the game.

Please Read The Following Rules Carefully. If You Have Any Questions, Please Ask A Member Of Our Staff.

Masks Must be worn at all times when on the field, in the chronograph area or any other "Masks On" designated zone. Do not lift your mask for any reason. If you need to adjust your mask please leave the playing field first.

Only paintballs bought at the field are allowed. No outside paint is to be brought or used on the property, including the chrono area.

The maximum velocity of your marker is 280fps. This speed is set in the chronograph area. Please ask a referee if you need assistance setting your marker speed.

This is a semi-auto field only, i.e., one ball per pull of the trigger.

Do not dry fire your marker in the staging area. Only discharge your marker in the playing field or chronograph range.

In order to eliminate a player or be eliminated you must tag them with a paintball once, anywhere on the body or equipment. The ball must break on target, bounce shots and splatter will not count. When in doubt, a quarter sized amount of paint will count as a hit.

When you are tagged you will raise your marker in the air and declare yourself out. You must then exit the playing field by the fastest and safest route, keeping your marker in the air. When you reach the exit, safety your marker and place the sleeve over the barrel before entering the staging area. When you have declared yourself hit you may not re-enter the game for any reason.

If you sneak up on a player please offer them the chance to surrender before tagging them.

Please take care on our playing fields. Pace yourself and move carefully around obstacles whether they are man made or natural.

Do not Shoot at Referees or any other staff members.
